<p>The use of prequalification and assessment criteria that can be applied to encourage ethical/responsible sourcing in the procurement process</p>	<p>Engage with stakeholders to agree prequalification and assessment criteria that can be applied to encourage ethical/responsible sourcing</p>
<p>Sources of information and databases that examine ethical practices</p>	<p>Carry out research and map supply chains to assess vulnerabilities and risks in supply that may result in breaches of ethical standards</p>
<p>The importance of obtaining supporting information on ethical practices in supplier quotations and tenders</p>	<p>Undertake due diligence on suppliers to evaluate the risks of forced labour and other human rights abuses, fraud and corruption</p>
